

THIVA BVBA DIMITRI VEGAS & LIKE MIKE SUBSCRIBE & WIN - COMPETITION RULES

ARTICLE 1

THIVA BVBA, with its registered offices at Jordaenskaai 23 / 201 at 2000 Antwerp, with enterprise number 0827.401.783 is organizing a competition without purchase obligation, which will start on 18/01/2021 and end on 18/06/2021, until 11:59pm.

ARTICLE 2

Participation in this competition is open to all individuals aged 14 or over, with the exception of: staff members of THIVA BVBA and its partners, and any other persons who worked on setting up the current competition.

The following persons are also excluded from participating in this competition: family members in the first degree of the persons listed in the previous paragraph, as well as persons residing at the same permanent address as the persons listed in the previous paragraph.

By entering the competition, participants will be deemed to have accepted these competition rules without any reservation. No disputes will be accepted regarding the wording of the questions and concerning the answers to the questions.

ARTICLE 3

In order for an entry into the competition to be valid, participants must enter via <https://win.dimitrivegasandlikemike.com>. On this page the participants have to enter the competition by confirming that they would like to subscribe to Spotify. When the participant has confirmed this, they have to click on 'Subscribe & Win' to complete the competition. A question is added and an answer to this tiebreaker question is mandatory in order to validly participate in the competition. Valid participants are eligible to win a prize. If there are too few or no correct answers to the question (s), so that the prize (s) cannot be allocated, the remaining prize (s) will be awarded to the participant (s) who give the closest correct answer. In the event of a tie, an additional tiebreaker question is asked and / or by drawing it is determined who will ultimately win a prize.
